The scope of Incentive Exam & CPD Exam has already been extended to DAO-I & Sr. DAO tier of the Composite Cadre of Divisional Accountants vide nos. under reference.

Extension of the IE-II and CPD Exams has not only enhanced the professional efficiency of the officials of the cadre but also opened an opportunity to assess the broad spectrum functionalities of the CAG of India on Audit and Accounts of the Union and State Governments and has boosted the moral of the officials as well. A considerable nos. of our cadre members have already passed the extended Departmental/Professional examinations in the meantime.

The basic grade Divisional Accountant in Level-6 and DAO-II in level-7 are at present not getting any scope for Departmental/ Professional Examinations unlike mainstream officials.

The entire cadre is functioning in the Public Works Division offices of respective State Govt. Engineering Depts. and are discharging Code specified responsibilities "as an 'Internal Checker' in Engineering Departments as the first stage of Audit. (CAG's MSO (Audit) 2nd Edition 2002 Para 4.1.3)".

Hence, Extension of Departmental/ Professional Examinations to D.A & D.A.O-II tier of the Composite Cadre of Divisional Accountants in line with the analogous mainstream cadre is prayed for to enhance the capacity building of the officers under IAAD.
