Sub: - Inclusion of DA Cadre for deputation outside IA&AD – Regarding. Ref: - Your No.1050 – Staff (App) – I /05-2022 date 28.06.2022. Respected Sir,

I am directed to draw your kind attention towards the aforementioned reference, wherein deputation policy for non-IA&AS officers for deputation outside IA&AD have been approved.

It is pertinent to mention that apart from other cadres, Divisional Accountant cadre is also a cadre under your administrative control. The Divisional Accountants are confirmed in their post only after successful completion of the probation period and clearing the Divisional Accountant Grade Examination (DAGE). Their functions are, as an accountant to compile accounts of the division, as an internal checker to apply certain preliminary checks to the accounts and vouchers of the division, as financial advisor to assist and advice the Divisional Officer in all matters relating to the accounts and budget estimates or to the operation of financial rules. The Divisional Accountant is treated as the senior member of the office establishment of the division and is well trained and conversant with the accounting procedures. As per note 3 para 4.2.1 of CPWA Code, *"the term Divisional Accountant will include Selection Grade Divisional Accountant/Junior Accounts Officer/Assistant Accounts Officer"*.

Regarding deputations it is observed that, requisitions for deputation from various departments outside IA&AD seek for willing eligible officers wherein eligibility criteria include mainly pay level along with specified years of service experience but while reproducing the advertisement by the office of the C&AG for circulation under IA&AD, applications are only invited from the eligible ranks of officers of main stream cadre of IA&AD, thus, excluding officers from DA cadre of IA&AD despite having equivalent qualification/criteria for the purpose. Some circulars are appended herewith for ready reference.

Date: 14.02.2025

The referred circular does not specifically exclude Divisional Accountants cadre from deputation but para (iii) of the circular only mentions about the Sr AO and AAO for calculating the vacancy as such there is a notion that Divisional Accountants are not eligible for deputations.

Divisional Accountants have a vast experience in works accounts, they are also entrusted with the work of tender evaluation, court cases, works agreement management, scrutinizing works bills and other bills for payment, clearing audit objections, checking pay bills and other entitlements of staff and any other related works. Further their Pay levels are also at par with the main stream cadres. Thus, Divisional Accountants are in every way eligible for deputations. Hence it is humbly requested that the cadre members may also be considered for deputation outside IA&AD.
