Subject: Instructions - Nomination of Divisional Accountant Cadre officials for five days Capacity Building Training Programme at ESCI, Hyderabad – reg.

Madam/Sir,

As part of the Capacity Building initiatives under the MoU between the Office of the Comptroller and Auditor General of India and the Engineering Staff College of India (ESCI), the Competent Authority has approved conduct of a five-day Capacity Building Training Programme on “Preparation of Estimates & DPR for Engineering Projects & Works” at ESCI, Hyderabad.

2. In this regard, reference is invited to the communication received from Capacity Building Wing vide email dated 11.05.2026 (copy enclosed) regarding conduct of five days Capacity Building Training Programme on “Preparation of Estimates & DPR for Engineering Projects & Works” at Engineering Staff College of India (ESCI), Hyderabad from 25th May to 29th May 2026.

3. The Divisional Accountant Cadre is presently functioning in 18 States (19 offices) under PAsG/AsG (A&E) offices, comprising approximately 4000 officials in various grades viz. Divisional Accountants (DAs), Divisional Accounts Officers Grade-II, Divisional Accounts Officers Grade-I and Senior Divisional Accounts Officers.

4. It has been planned to cover all officials of the cadre under the training programme within a period of two years.

5. In order to ensure equitable participation of all offices, the following guidelines shall be followed for nomination and smooth conduct of training:

- i. All offices having Divisional Accountant Cadre, including Mumbai office, shall normally nominate two officials for each batch of training. Offices of Bihar, Jharkhand, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh and West Bengal shall normally nominate three officials for each batch keeping in view the larger cadre strength.
- ii. Offices may suitably plan nominations for different batches to ensure equitable coverage of officials from all grades/categories of the DA Cadre, viz. DA, DAO-II, DAO-I and Sr. DAO, during the two-year training cycle. After successful completion of training programme, entry for the same may be made in their Service Book.

- iii. Officials who are likely to superannuate within the next one year or those presently under probation (DA probationer) may be excluded from nomination.
- iv. Care may also be taken to ensure that the Link Charge officers from an office are not nominated in the same batch.
- v. Ensure timely submission of nominations to the Capacity Building Wing of Headquarters Office (kcbwing@cag.gov.in), under intimation to Government Accounts Wing, as and when called for.
- vi. HODs may liaison with the State Government for release of the nominated DA cadre officials for smooth conduct of the training.
- vii. TA/DA in respect of the nominated officials shall be regulated as per extant rules applicable to DA Cadre officials.
- viii. Boarding and lodging arrangements will be made by the Institute.

6. Nominations for the first batch scheduled from 25th to 29th May 2026 may be furnished to the Capacity Building Wing (kcbwing@cag.gov.in), under intimation to Government Accounts Wing positively by **14th May 2026**.
